There was no action taken on this item. City Attorney, Daniel Ray, addressed the City Council and audience concerning an incident that occurred at the Wolfe City Donut Shop on December 29, 2017 and recommended that the City Council take no action against Gene Peoples for his actions at the Wolfe City Donut Shop and that his actions were within his training as a licensed Peace Officer. Mr. Peoples was required to act according to his training and judgment as a peace officer, and his actions were appropriate given the events and unknowns in this situation. The City Attorney said that general city employees should not be allowed to carry a gun, but Gene Peoples is a licensed peace officer and required to carry his gun and required to be on duty in this type of situation. Mr. Peoples should not have stayed inside of the donut shop after the car struck the building. He did what he is trained to do as a peace officer and what the city should have expected him to do. The City Attorney recommends that the City Council does not take any action against Gene Peoples for his actions in this situation and recommends that that the City Council stick with its current policy to not allow City Employees who are not licensed peace officers to carry weapons while working for the city.
