## NOTICE OF PUBLIC HEARING ON TAX INCREASE

A tax rate of \$0.653141 per \$100 valuation has been proposed by the governing body of CITY OF WOLFE CITY.

The no-new-revenue tax rate is the tax rate for the 2022 tax year that will raise the same amount of property tax revenue for CITY OF WOLFE CITY from the same properties in both the 2021 tax year and the 2022 tax year.

The voter-approval rate is the highest tax rate that CITY OF WOLFE CITY may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that CITY OF WOLFE CITY is proposing to increase property taxes for the 2022 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON September 12, 2022 AT 05:30 PM AT City of Wolfe City Meeting Room 103 W Main Wolfe City, Texas 75496.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, CITY OF WOLFE CITY is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Wolfe City City Council of CITY OF WOLFE CITY at their offices or by attending the public hearing mentioned above.
