Special Meeting Minutes
June 25th, 2026
6:00 p.m.**

The City Council of the City of Wolfe City, Texas, held a Special Meeting at the date, time, and location listed above to consider and act upon the following items:

1. Mayor Sharion Scott called the meeting to order at 6:03 pm
2. Council Members Darlene Dawson, Ian Martinez, Brad Moore, Matt Webb and Rusty Shreeves were all present creating a quorum.
3. Council Member Rusty Shreeves led the invocation.
4. Pledge of Allegiance conducted
5. A discussion was held regarding Resolution No. 2026-0625-1 authorizing the Wolfe City Economic Development Corporation to fund improvements to Preston Street and approving an interlocal Cooperation Agreement with Hunt County.

No Action was taken. This item will be presented for a second reading at the regular meeting on July 13th.

6. Council Member Matt Webb moved to table consideration of the variance request until the property owner and/or realtor attend a future meeting to explain the proposed development of the property. Council member Darlene Dawson seconded the motion. The motion carried unanimously.
7. Jeremy Kinkade presented information regarding the condition of the wastewater treatment plant pump and the need for repair or replacement. Council discussed the urgency of the project due to the operation of the wastewater treatment system. Council Member Matt Webb moved to authorize the replacement or repair of the wastewater treatment plant pump in an amount not to exceed \$70,000.00. Council Member Ian Martinez seconded the motion. The motion carried unanimously.
8. The City Council convened in Executive Session at 6:44 p.m. pursuant to the following provisions of the Texas Government Code:
 - Pursuant to Texas Government Code Section §551.074 (Personnel Matters): Deliberation regarding salary range and compensation package for the Police Chief position.
 - Pursuant to Texas Government Code Section §551.071, consultation with the City Attorney regarding legal issues associated with City's wastewater treatment facilities and the proposed wastewater pump replacement or repair.

9. The City Council Reconvened into Open Session to take possible action regarding items discussed in Executive Session at 7:14 pm
 - Council Member Matt Webb moved to approve a starting salary of \$68,000.00 per year for the Chief of Police position, with annual salary increases of \$2,000.00 until the salary reaches \$74,000.000 including allowing the Wolfe City Police vehicles to be taken home not to exceed a 30 mile one way trip. Rusty Shreeves seconded the motion and the motions passed unanimously.
10. Council Member Rusty Shreeves motioned to adjourn the meeting at 7:21. Council Member Brad Moore seconded the motion, and it passed unanimously.
